# Philmont 2003 NCAC Provisional Contingent Trip YOUTH APPLICATION

The National Capital Area Council High Adventure Committee each year offers the opportunity for individual Scouts and Venturers to form into Provisional crews for trips to Philmont

Scout Ranch. All requests for spaces on NCAC Provisional Philmont expeditions must be submitted by the parent or guardian of a specific individual Scout or Venturer - Unit, Patrol, Crew or other forms of group reservation requests are not accepted for these contingents, and requests for more than one participant from the same family must be submitted separately. Since provisional crews are formed based on the interests of the youth participants who form the contingent, individuals from the same Unit/Patrol/Crew who apply for the same contingent date are **not guaranteed or required** to become members of the same crew. Similarly, adults from a Unit/Patrol/Crew that apply separately for Crew Advisor positions are **not guaranteed or required** to eventually be affiliated with youth from their own Unit/Patrol/Crew. Experienced High Adventure Committee members will assist in crew formation activities for Philmont contingents once contingents have been filled out.

Youth members must be 14 years old by January 1, 2003, or have completed the 8th grade and be 13 years old prior to arrival at Philmont, to be eligible to attend Philmont in 2003.
